We believe the current opportunity for applicants from Latin American countries to use the E visas to enter the U.S. could not be better. Europe and Asia has successfully used this visa for many years while numerous South American countries have not (as evidenced by the chart to the right from the U.S. Department of State).

The treaties allow entry into the U.S. any qualifying applicant who applies and meets the qualifications; with the most important step being applying. Don't let this opportunity pass you by, treaties agreements are not forever.

The "significant" investment requirement which applies to the E2 visa is not quantified by the treaty since the actual amount is not what determines qualification but rather the business capitalization aspect. Whether the capitalization is for \$25,000 or \$125,000 the business plan will explain the success probability of the business. The U.S Consulate office relies primarily on the business plan to accept or reject applications.
